**CORRIGENDUM**

**Subject: Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postman and Mail Guard from eligible Multi-Tasking Staff officials for the vacancy year 2026 (01.01.2026 to 31.12.2026).**


In accordance with Postal Directorate letter No.DE-12/3/2026-DE-DOP dated 26.05.2026 and letter No.03-03/2019-SPN-I dated 11.06.2026, this is to inform all Applicants, Regions and Divisions/Units that a corrigendum, to the Notification No.REP/5-1/2026 dated 01.06.2026 for the Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postman and Mail Guard from eligible Multi-Tasking Staff for the vacancy year 2026 (01.01.2026 to 31.12.2026), is issued hereby.

2. As directed by Postal Directorate vide letter No.03-03/2019-SPN-I dated 11.06.2026, the relaxation of one year in service eligibility condition has been given to MTS. Accordingly, in partial modification of the Notification No.REP/5-1/2026 dated 01.06.2026 for promotion to the post of Postman and Mail Guard, the eligibility service prescribed for the categories of officials mentioned at (i) and (ii) under the heading "Eligibility Criteria" shall be read as follows:

- i. **Multi Tasking Staff (MTS)** in Level-1 of the Pay Matrix with **two years** of regular service as on crucial date (01.01.2026) shall be eligible for appear in the Limited Departmental Competitive Examination for promotion to the posts of **Postman/Mail Guard**.
- ii. **Multi Tasking Staff (MTS)** in Level-1 of the Pay Matrix with with **total regular service of four years**, including service rendered as **Gramin Dak Sevaks (GDS)**, as on the crucial date (01.01.2026), shall be eligible to appear in the examination.

3. The above relaxation is a one-time measure applicable only for the vacancy year 2026 and shall not be treated as a precedent

4. All other entries in the original notification holds good.


